8. Successful applicants must show up in the fair and complete a questionnaire when collecting the reimbursement at the "Buying Mission Check-in Counter" in the fairground.
9. The original copy of acknowledgement letter, passport with landing slip, business card, boarding pass and e-ticket receipt **MUST BE** presented upon the reimbursement collection. The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
